

# Florida's Advanced Practice Nurses Supply and Demographic Data 2010-2011

This brief report outlines Advanced Practice Nurse (APN) supply and demographic data from the 2010-2011 Florida Nurse Licensure Renewal database and the Florida Center for Nursing Workforce Survey.<sup>1</sup> Recognizing the need for an accurate understanding of the APN population in FL, this analysis establishes baseline data in preparation for the 2014 report. APN licenses in Florida are defined by the categories Advanced Registered Nurse Practitioner and Clinical Nurse Specialist. An FCN survey question further identifies the existence of a certification with these responses: Certified Nurse Midwife (CNM), Certified Registered Nurse Anesthetist (CRNA), Both, or Neither. Those APNs with neither certification will be referred to as Nurse Practitioners (NP). Eleven percent of Advanced Practice Nurses did not answer the optional survey.



NOTE: The Potential Nurse Workforce represents those APNs who have an active license, Florida address, and no disciplinary restrictions.

The number of APNs in Florida has steadily increased since the Center began tracking data in 2006-2007.<sup>1</sup> The potential APN workforce are those with an active Florida license, Florida address, and no disciplinary restrictions. The potential workforce grew from 11,094 in 2006-07 to 14,103 in 2010-11. The Center estimates that 91 percent of those APNs are working in nursing.
